

## **Youth Fest – Mini Canvas Competition**

### **Full Terms and Conditions**

#### **1. General**

The Promoter is *Myli – My Community Library Ltd [ABN 92 653 088 610] (Myli)* of 2/65 Victoria Street, Warragul VIC 3820. Telephone (03) 5622 2849.

Information on how to enter and prizes form part of the terms of entry. Entry into the competition is deemed acceptance of these terms and conditions.

If there is any inconsistency between these Terms and Conditions and anything else that refers to this competition, these Terms and Conditions will prevail.

#### **2. Who can enter**

Entry is open to *MYLI members aged between 12 and 25* except employees and immediate families of the Promoter and their associated companies and agencies. Immediate family includes the following: spouse, ex-spouse, defacto spouse, child or step child (whether natural or by adoption), parent, step parent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, step brother, step sister or first cousin.

Entrants must be *aged between 12 and 25* to enter the competition. Entrants under the age of 18 years of age must complete their entry with a parent or guardian in order to be eligible to enter the competition.

The Promoter reserves the right to request winners to provide proof of identity, proof of residency at the nominated prize delivery address and/or proof of entry validity or proof of registration ownership in order to claim a prize. Proof of identification, residency and entry considered suitable for verification is at the discretion of the Promoter. In the event that a winner cannot provide suitable proof, the winner will forfeit the prize in whole and no substitute will be offered.

#### **3. When to enter**

Competitions commence on *17th September, 2022 and run when advertised through until 2<sup>nd</sup> October, 2022* or until Mini Canvas Supplies have run out. Entries must be received by the Promoter prior to the individual competition close dates and times.

The time of entry will be validated by staff in each time the entry is physically received by the Promoter.

The Promoter accepts no responsibility for any late, lost or misdirected entries due to technical disruptions, network congestion or for any other reason.

#### **4. How to enter**

*Pick up a Canvas from your local participating branch*

*Put your artwork on the canvas in any medium*

*Return your canvas to one of MYLI's participating branches with your name, contact number, email address and signature of guardian if under 18 (not on the canvas as these will be put on display, you can add your details on a separate sheet of paper to be recorded to go into the draw to win a prize).*

*Only one canvas and one entry per person*

Entrants are required to take full responsibility for the content of their entry and for ensuring that their entry complies with these Terms and Conditions. For the purposes of these content requirements, "entry content" includes any content (including text) that entrants submit in connection with their entry into the Promotion.

Any entry that is made on behalf of an entrant by a third party will be invalid unless the entrant requires the assistance of a third party to enter on behalf of a minor or due to a disability.

The Promoter reserves the right to disqualify any entrant who tampers with the entry process, who submits an entry that is not in accordance with these Terms & Conditions of Entry or who has, in the opinion of Promoter, engaged in conduct in entering the Promotion which is fraudulent, misleading, deceptive or generally damaging to the goodwill or reputation of the Promotion and/or Promoter. This includes, but not limited, to entrants and households using multiple email addresses.

## **6. Draw and Notification of winner**

The winner of each individual competition will be the first valid entry submitted in accordance with these Terms and Conditions that is drawn by *a Myli representative* by random barrel drawn *in October 2022 at 2/65 Victoria Street, Warragul VIC 3820.*

The Promoter's decision is final and the Promoter will not enter into correspondence regarding the competition result or any other decisions the Promoter makes in connection with the Promotion.

The winner will be notified by *phone or email* within 24 hours of the draw.

Should an entrant's contact details change during the promotional period, it is the entrant's responsibility to notify the Promoter. A request to access or modify any information provided in an entry should be directed to the Promoter.

If the winner cannot be contacted by phone and email within 48 hours of the draw, the prize will be forfeited and a second draw will be conducted

If subsequent winners cannot be contacted, the prize will be forfeited and a draw will be repeated until a winner can be contacted.

## **7. Prize on offer**

*The prize must be collected from a nominated branch.*

*The Winner and all travelling companions are responsible for their own transport arrangements from their residence to the nominated branch to collect the prize.*

Entrants need to enter each individual competition as they are advertised. Entry into one specific competition does not entitle the entrant to be automatically entered into every competition advertised.

Subject to complying with all relevant State and Territory legislation, the Promoter reserves the right to amend, cancel or suspend this competition if the competition beyond the control of the Promoter corrupts or affect the administration security, fairness, integrity or proper conduct of the competition. The Promoter will disqualify any individual who has tampered with the entry process or any other aspect of this competition.

The Promoter and their associated agencies and companies assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorised access to, or alteration of entries, and reserves the right to take any action that may be available.

If the prize is unavailable, for whatever reason, the Promoter reserves the right to substitute the prize for a prize of equal or greater value, subject to State and Territory legislation. It is a condition of accepting the prize that the winner must comply with all the conditions of use of the prize and prize supplier's requirements. Each prize must be taken as stated and no compensation will be payable if a winner is unable to use the prize as stated.

The Promoter reserves the right to redraw the prize if an entrant who claims to be a prize winner is unable to satisfy these terms and conditions.

However, the remainder of this clause will apply to the fullest extent permitted by law and the Promoter shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for any personal injury suffered or sustained in connection with the prize except for any liability which cannot be excluded by law. All entries will be entered into a database and The Promoter may use the entrant's names and email address for future promotional, marketing and publicity purposes in any media worldwide without notice and without any fee being paid unless otherwise advised by the entrant. If entrants no longer consent to their details being used for future marketing purposes, the entrant should contact The Promoter on their details set out below. Any request to update, modify or delete the entrant's details should be directed to The Promoter.
