

# 2023 Book Week Competition

## Full Terms and Conditions

### 1. General

The Promoter is Myli - My Community Library Ltd, ABN 92 653 088 610 (Myli) of 2/65 Victoria Street, Warragul VIC 3820. Telephone (03) 5622 2849.

Information on how to enter and prizes form part of the terms of entry. Entry into the competition is deemed acceptance of these terms and conditions.

If there is any inconsistency between these Terms and Conditions and anything else that refers to this competition, these Terms and Conditions will prevail.

### 2. Who can enter

Entry is open to all Myli Library members except employees and immediate families of the Promoter and their associated companies and agencies. Immediate family includes the following: spouse, ex-spouse, defacto spouse, child or stepchild (whether natural or by adoption), parent, stepparent, grandparent, step grandparent, uncle, aunt, niece, nephew, brother, sister, stepbrother, stepsister or first cousin.

Entrants may be any age to enter the competition. Entrants under the age of 18 years of age must complete their entry with a parent or guardian to be eligible to enter the competition.

The Promoter reserves the right to request winners to provide proof of identity, proof of residency at the nominated prize delivery address and/or proof of entry validity or proof of registration ownership in order to claim a prize. Proof of identification, residency and entry considered suitable for verification is at the discretion of the Promoter. In the event that a winner cannot provide suitable proof, the winner will forfeit the prize in whole and no substitute will be offered.

### 3. When to enter

Competitions commence on 12:00am AEST 19<sup>th</sup> August 2023 until 11:59 pm AEST on 25<sup>th</sup> August 2023. Entries must be received by the Promoter prior to the individual competition close dates and times.

The time of entry will be validated by staff in each time the entry is physically received by the Promoter.

The Promoter accepts no responsibility for any late, lost or misdirected entries due to technical disruptions, network congestion or for any other reason.

### 4. How to enter

Entrants may enter the competition by completing the competition entry form including a photo, short story or picture of their favourite character and physically submit their entry to staff at a branch or email to [connect@myli.org.au](mailto:connect@myli.org.au)

By entering the competition, participants agree to grant the promoter a non-exclusive, royalty-free, worldwide license to use their entry (photo, short story, or picture) for promotional and marketing purposes, both online and offline, without any further compensation.

Entrants are required to take full responsibility for the content of their entry and for ensuring that their entry complies with these Terms and Conditions. For the purposes of these content requirements, "entry content" includes any content (including text) that entrants submit in connection with their entry into the Promotion.

Any entry that is made on behalf of an entrant by a third party will be invalid unless the entrant requires the assistance of a third party to enter on behalf of a minor or due to a disability.

The Promoter reserves the right to disqualify any entrant who tampers with the entry process, who submits an entry that is not in accordance with these Terms & Conditions of Entry or who has, in the opinion of Promoter, engaged in conduct in entering the Promotion which is fraudulent, misleading, deceptive or generally damaging to the goodwill or reputation of the Promotion and/or Promoter. This includes, but not limited, to entrants and households using multiple email addresses.

#### 5. Number of Entries permitted

Multiple entries are permitted.

#### 6. Draw and Notification of winner

Entries will be judged based on creativity, originality, and adherence to the theme. The judging panel will consist of representatives appointed by the promoter. The panel's decision will be final and binding in all matters related to these Terms and Conditions in March at 2/65 Victoria Street, Warragul VIC 3820.

The winner will be notified by phone and/or email within 24 hours of the draw.

The prize will be awarded to the person named in the entry. However, in a dispute, will be awarded to the account holder of the entry mechanism used to submit their entry (i.e. Internet Service Provider account holder).

Should an entrant's contact details change during the promotional period, it is the entrant's responsibility to notify the Promoter. A request to access or modify any information provided in an entry should be directed to the Promoter.

If the winner cannot be contacted by phone and email within 48 hours of the draw, the prize will be forfeited and a second draw will be conducted

If subsequent winners cannot be contacted, the prize will be forfeited and a draw will be repeated until a winner can be contacted.

#### 7. Prize on offer

The Winner and all travelling companions are responsible for their own transport arrangements from their residence to the nominated branch to collect the prize.

Subject to complying with all relevant State and Territory legislation, the Promoter reserves the right to amend, cancel or suspend this competition if the competition beyond the control of the Promoter corrupts or affect the administration security, fairness, integrity or proper conduct of the competition. The Promoter will disqualify any individual who has tampered with the entry process or any other aspect of this competition.

The Promoter and their associated agencies and companies assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorised access to, or alteration of entries, and reserves the right to take any action that may be available.

If the prize is unavailable, for whatever reason, the Promoter reserves the right to substitute the prize for a prize of equal or greater value, subject to State and Territory legislation. It is a condition of accepting the prize that the winner must comply with all the conditions of use of the prize and prize supplier's requirements. Each prize must be taken as stated and no compensation will be payable if a winner is unable to use the prize as stated.
